PRIVACY POLICY for www.napfmevent.org.uk

Wiltshire Police and the National Association of Police Fleet Managers are committed to safeguarding and preserving the privacy of our visitors.

This Privacy Policy explains what happens to any personal data that you provide to us, or that we collect from you whilst you visit our site.

We do update this Policy from time to time and may review this Policy from time to time.

Information We Collect

In running and maintaining our website we may collect and process the following data about you:

- i. Information about your use of our site including details of your visits such as pages viewed and the resources that you access.
- ii. Information provided voluntarily by you. For example, when you register as a delegate, visitor or exhibitor.
- iii. Information supplied to us by exhibitors and delegates for publishing in the conference brochure.

Cookies

A cookie is a small piece of information written to a user's hard drive that provides information about the user. Cookies and other covert technologies are not used on the NAPFM Event website.

Use of Your Information

The information you give us is used to provide our services to you. In addition to this we may use the information for one or more of the following purposes:

- i. To provide information to you that you request from us relating the NAPFM Conference & Exhibition or similar events.
- ii. To provide information to you relating to the current and future NAPFM Events. (If you do not wish to receive information regarding future events please email napfm.conf@wiltshire.pnn.police.uk)
- iii. To inform you of any changes to our website, the NAPFM Event, service or goods and products.

The information provided voluntarily by people wishing to register as Visitors to the NAPFM Event is used to ensure that it meets the visitor criteria as described on the Visitor Home Page.

Visitors registering to attend the NAPFM Event will be processed by Show Data Ltd through their website; this is to allow for the production of passes for the event.

Where your consent has been provided in advance we may allow selected third parties to use your data to enable them to provide you with information regarding unrelated goods and services which we believe may interest you. Where such consent has been provided it can be withdrawn by you at any time.

Information provided by exhibitors, such as contact details and brochure entry information may be shared with selected publishers approved by the NAPFM Event Team. Further information regarding this is contained in the Exhibitors Terms and Conditions.

The names of staff exhibiting at the event will also be handled by Show Data for the production of passes.

Storing Your Personal Data

In operating our website it will not be necessary to transfer data that we collect from you to locations outside of the European Union for processing and storing.

Unfortunately the sending of information via the internet is not totally secure and on occasion such information can be intercepted. We cannot guarantee the security of data that you choose to send us electronically. Sending such information is entirely at your own risk.

Disclosing Your Information

We will not disclose your personal information to any other party other than in accordance with this Privacy Policy and in the circumstances detailed below:

- i. In the event that we sell any or all of our business to the buyer.
- ii. Where we are legally required by law to disclose your personal information.
- iii. To further fraud protection and reduce the risk of fraud.

On occasions we include links including hyperlinks to third parties on this website. Where we provide a link it does not mean that we endorse or approve that site's policy towards visitor privacy. You should review their privacy policy before sending them any personal data.

Access to Information
